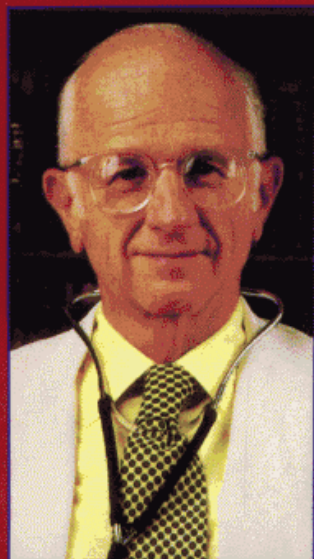

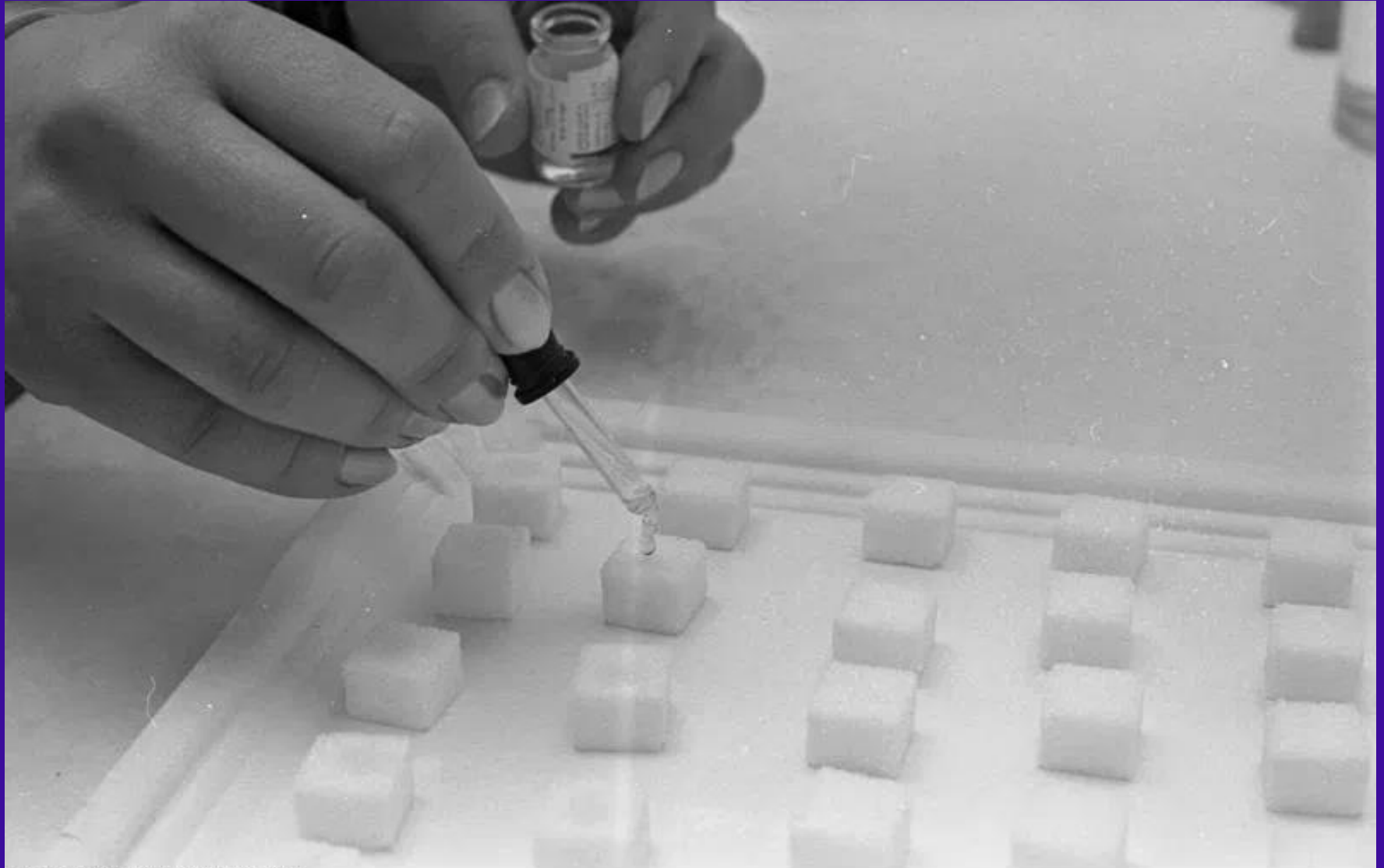

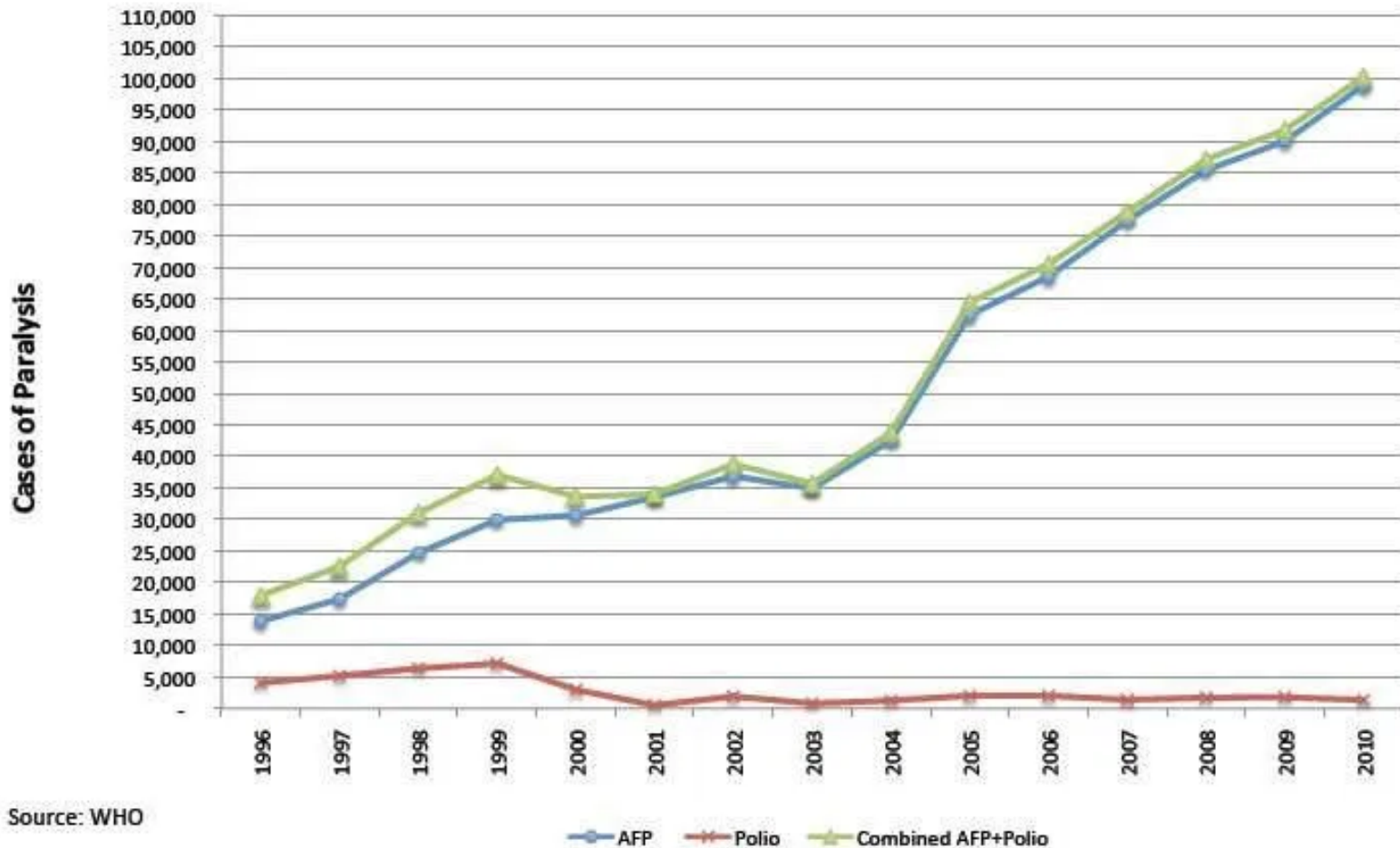

# Banned Vaccines

- Live Sabine Polio Vaccine  
Discontinued in the US in 2000  
because the vaccine was causing VAPP,  
vaccine associated paralytic polio.
- The Swine Flu vaccine was banned in  
1976 because of increased Guillan  
Barre syndrome after vaccination. etc.



# Banned Vaccines - DTP

- The whole cell pertussis vaccine was associated with increased mortality in children receiving the vaccine.
- In Sweden, whole cell pertussis vaccination was suspended in 1979, and was later replaced with a safer acellular Pertussis vaccine.
- In Japan, DTP vaccination was banned in 1993 due to safety concerns.



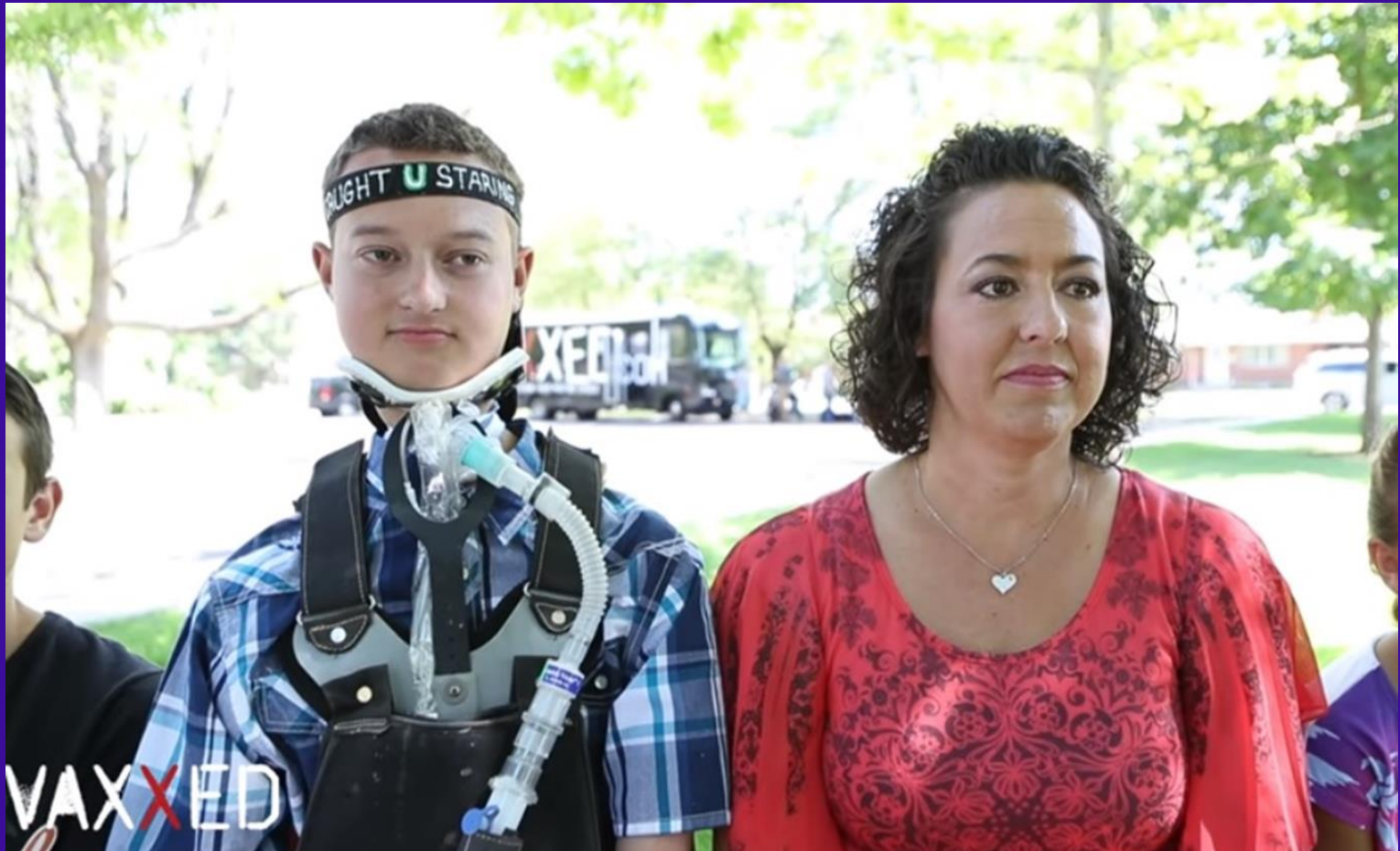
# 5-Fold Increased Mortality with DTP Vaccine

- “DTP (vaccine) was associated with 5-fold higher mortality than being unvaccinated. No prospective study has shown beneficial survival effects of DTP vaccine”

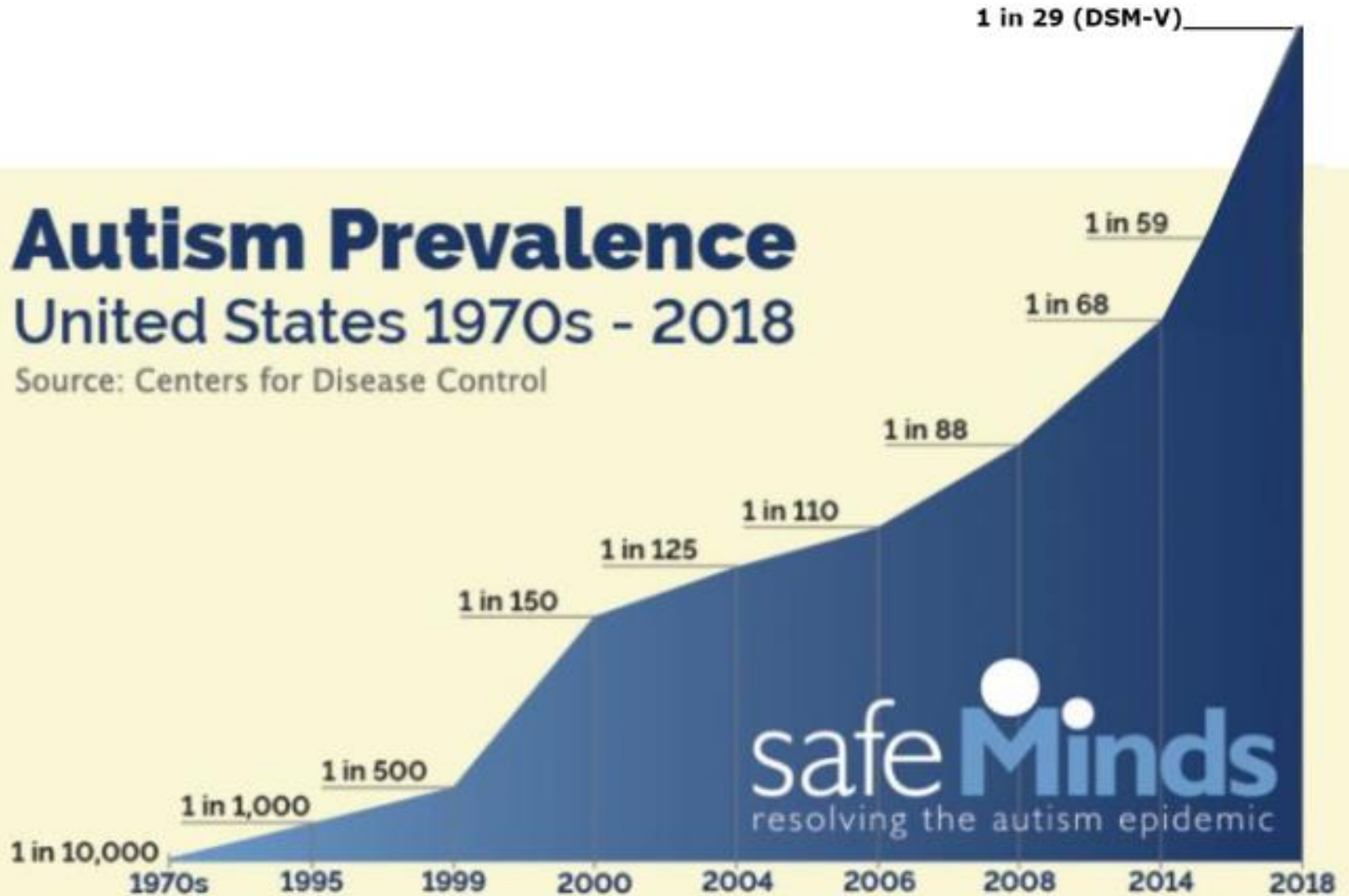
# Hep B Vaccine

- 1994 IOM Report in NAS concluded :
- There Were No Case Controlled Observational Studies or Controlled Clinical Trials conducted on hepatitis B vaccine either before or after licensure to scientifically evaluate persistent reports that Hepatitis B vaccine can cause SIDS (sudden infant death syndrome); Guillain-Barre syndrome (GBS) and other central demyelinating diseases including transverse myelitis, optic neuritis, and multiple sclerosis; and immune system dysfunction including chronic arthritis.

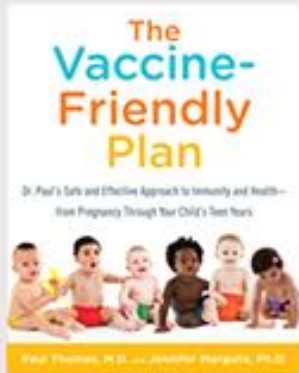

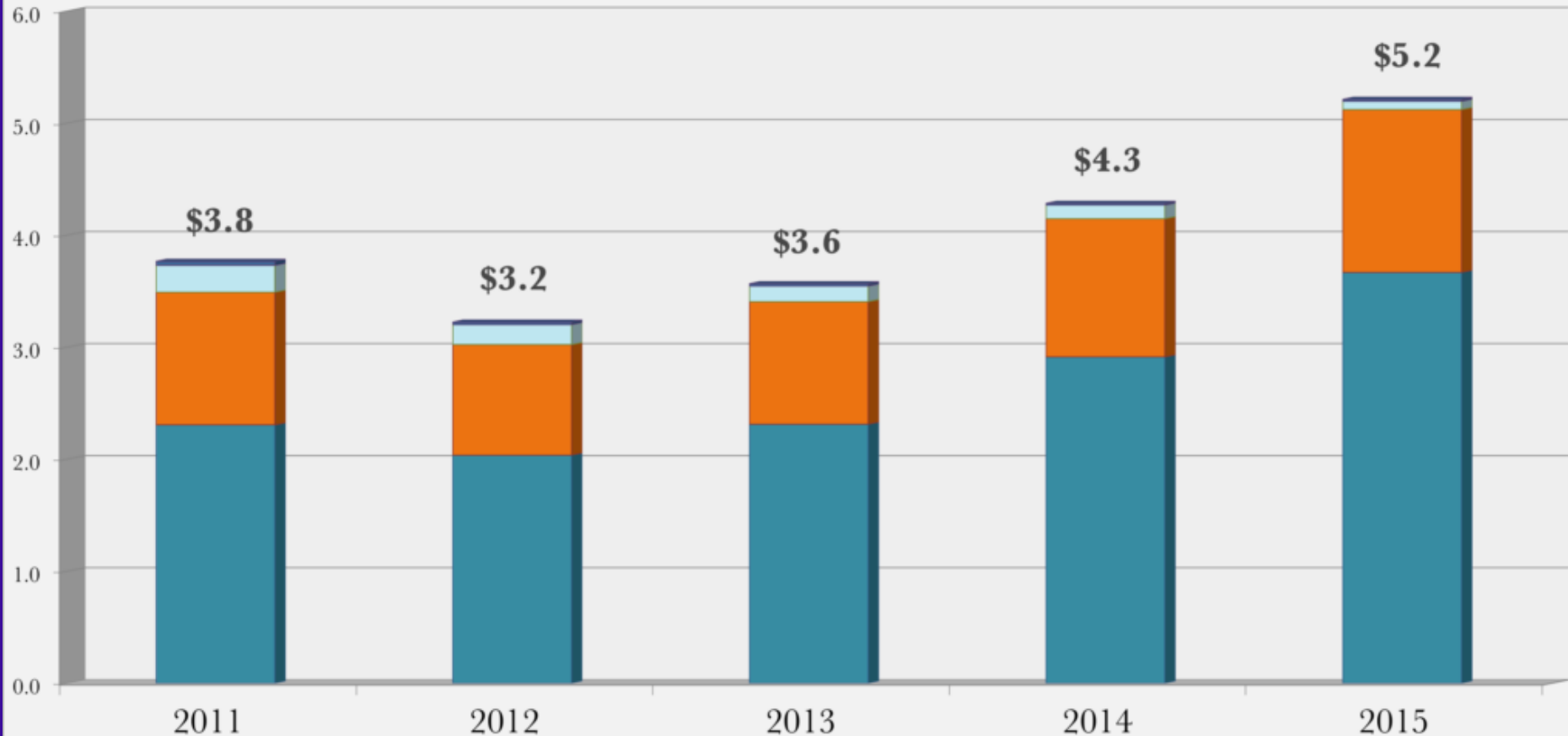

# AMA Policy - June 13, 2019

- AMA Advocates: “Eliminate Non-Medical Vaccine Exemptions.”
- “The overwhelming scientific evidence shows that vaccines are among the most effective and safest interventions to both prevent individual illness and **protect the health of the public.**”

# CDC

- Vaccination is one of the “Ten Great Public Health Achievements in the 20th Century”

# What Are the Arguments ?

- 1) Legislators are Lawyers Cannot Read Nor Understand Science , So They Accept Authority of Experts from AMA and CDC .
- 2) Increasing Vaccine Uptake is Equated with Protecting Public Health. (Robert Wiggins, Steuben County NY Supreme Court)
- 3) Civil Rights, Religious Rights, Personal Autonomy Argument – Works for Republicans But Not Democrats.

# The NY Supreme Court- Religious Exemption Repeal Challenge

- Increasing Vaccine Uptake is Equated with Protecting Public Health. (Robert Wiggins, Steuben County NY Supreme Court)
- “The Court reiterates its displeasure with the Legislature’s apparent callous disregard for the sincere religious convictions of Plaintiffs and others similarly situated,”
- Judge Wiggins Described it as: “Draconian.”
- Yet still Upheld The State’s Case

# How to Win a Political Battle

## Nuts and Bolts

- Know Your Opponent- Big Pharma is the Elephant in the Room.
- Identify Legislators (D) Who Represent Big Pharma – Seek Their Overthrow by Supporting and Campaigning for their Opponents.
- Identify Sympathetic Allies (R) who Represent the People – Help by Campaigning, Contributing etc.
- Unite with Like Minded Organizations-NVIC- Children's Health Defense, Political Experts etc..
- People Power- Telephone Banks, Door-to Door, Street Demonstrations, Flash Mob etc.
- Have a Well Thought Out Legislative Agenda

# Legislative Agenda

- 1) Repeal 1986 Vaccine Act, Restore Liability to Vaccine Makers for Product Injury. (Discovery - Jury Trial.)
- 2) Reclassify Vaccines from Biologics to Drugs Requiring Placebo Controlled Randomized Trials for Approval and Licensing same as any other Drug. (10% later banned)
- 3) Vaccine Adjuvants (AI) are to be classified as New Drugs, which require separate placebo controlled safety testing for the adjuvant.
- 4) Replace or Update VAERS so it captures 100% of all vaccine injuries and deaths, using a team of trained health professionals to track all vaccine events which are followed for at least one year, with 100% of all adverse events entered into the database..

# Legislative Agenda

- 6) Ban Direct Consumer Drug Television Advertising as all other industrialized countries have done (with the exception of New Zealand)
- 7) Ban Financial Kickbacks to Pediatricians from insurance companies for childhood vaccinations.
- 8) Ban the payments to hospitals for vaccination quotas for patient vaccinations.
- 9) Ban the use of vaccination status as a prerequisite for employment for hospital nursing staff and other health professionals.
- 10) CME's: Health professionals such as Pediatricians, and Pediatric Nurses will require 1 hour CME in recognizing and reporting vaccine adverse effects, the history of past discontinued (failed) vaccines etc., .



# Financial Kickbacks to Pediatricians

Blue Cross Blue Shield pays your doctor a \$40,000 bonus for fully vaccinating 100 patients under the age of 2. If your doctor manages to fully vaccinate 200 patients, that bonus jumps to \$80,000.

But here's the catch: Under Blue Cross Blue Shield's rules, pediatricians **lose the whole bonus**

unless at least 63% of patients are fully vaccinated, and that includes the flu vaccine. So it's not just \$400 on your child's head—it could be the whole bonus. To your doctor, your decision to vaccinate your child might be worth \$40,000, or much more, depending on the size of his or her practice.





# 1988 - Ethics in Patient Referrals Act

- Anti-Kickback Statute (AKS)
- Physician Self-Referral Law (Stark law)
- False Claims Act (FCA)
- Violation: Criminal penalties, Civil fines, Exclusion from the Federal health care programs, or Loss of Medical License (medical board)."

# Legislative Agenda

- 9) Mandate Serologic - Genotype Testing for all viral disease cases to determine if the "epidemic" is caused by a vaccine strain virus.
- 10) Ban the use of vaccines during pregnancy unless the vaccine has been prospectively tested for safety and efficacy in Pregnant Women.
- 11) Ban the use of the Hepatitis B vaccine in newborns unless the mother tests positive for hepatitis B.
- 12) Pass resolutions condemning censorship of discussions questioning vaccines. We need a free and open debate.

# Legislative Agenda

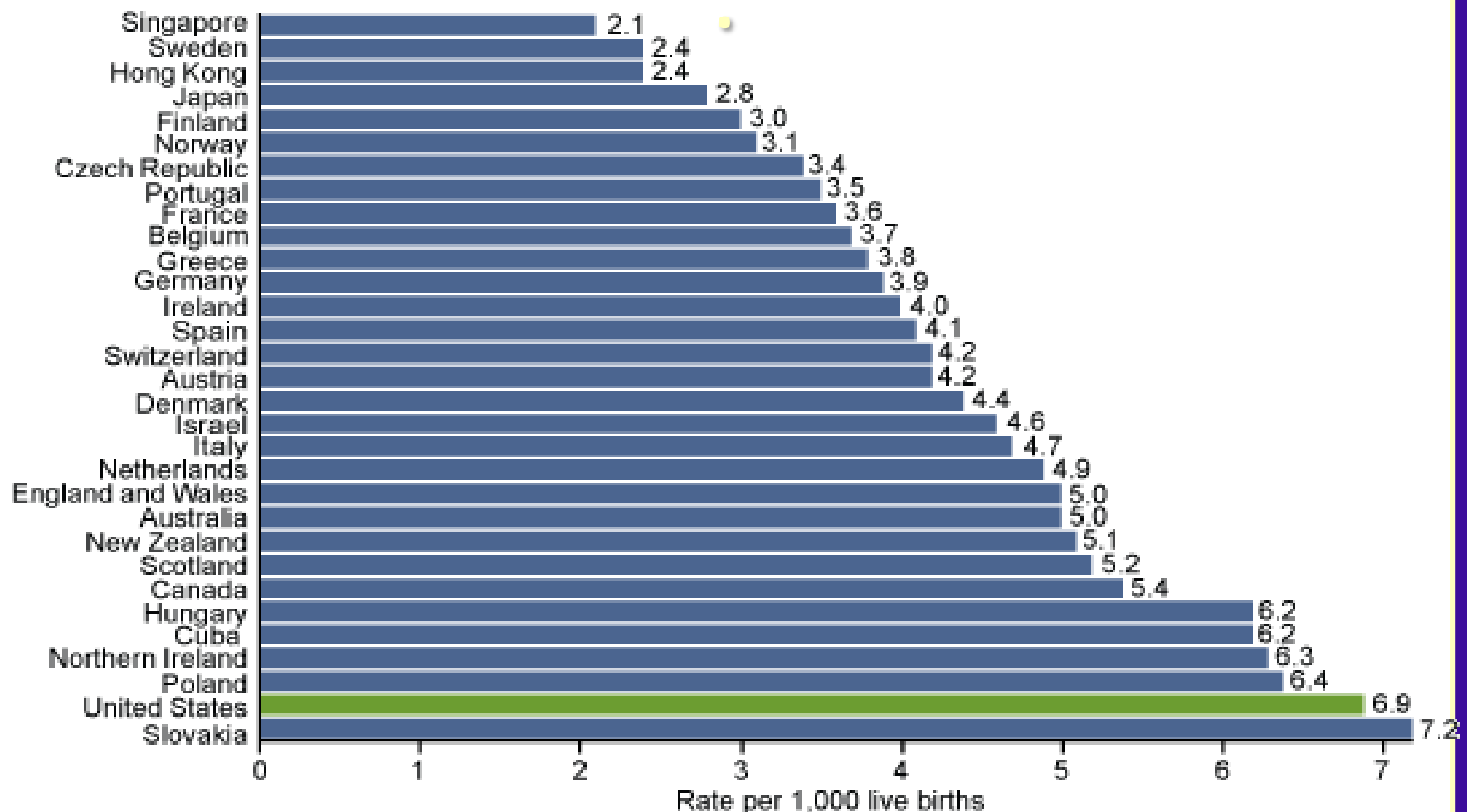
- 13) Open a Congressional Inquiry into William Thompson Whistleblower at the CDC claiming fraudulent manipulation of DATA. DeStefano 2004 MMR African-Amer Males.
- 14) Open a Congressional Inquiry into the Andrew Zimmerman case whose expert testimony, “ That Vaccines Can Cause Autism in some cases” ....was suppressed and fraudulently misrepresented by federal vaccine court lawyers.

# Why is Japan Healthier with Voluntary Vaccines ?

- 15) Open a Congressional Inquiry on “Why USA has Highest Infant Mortality Rate and Japan Lowest ?”
- Japan Banned Hep B 1st Day.
- Japan Banned DTP.
- Japan D/C MMR vaccine 1993: three separate injections for MMR.
- No Requirement for Vaccines for School Entry

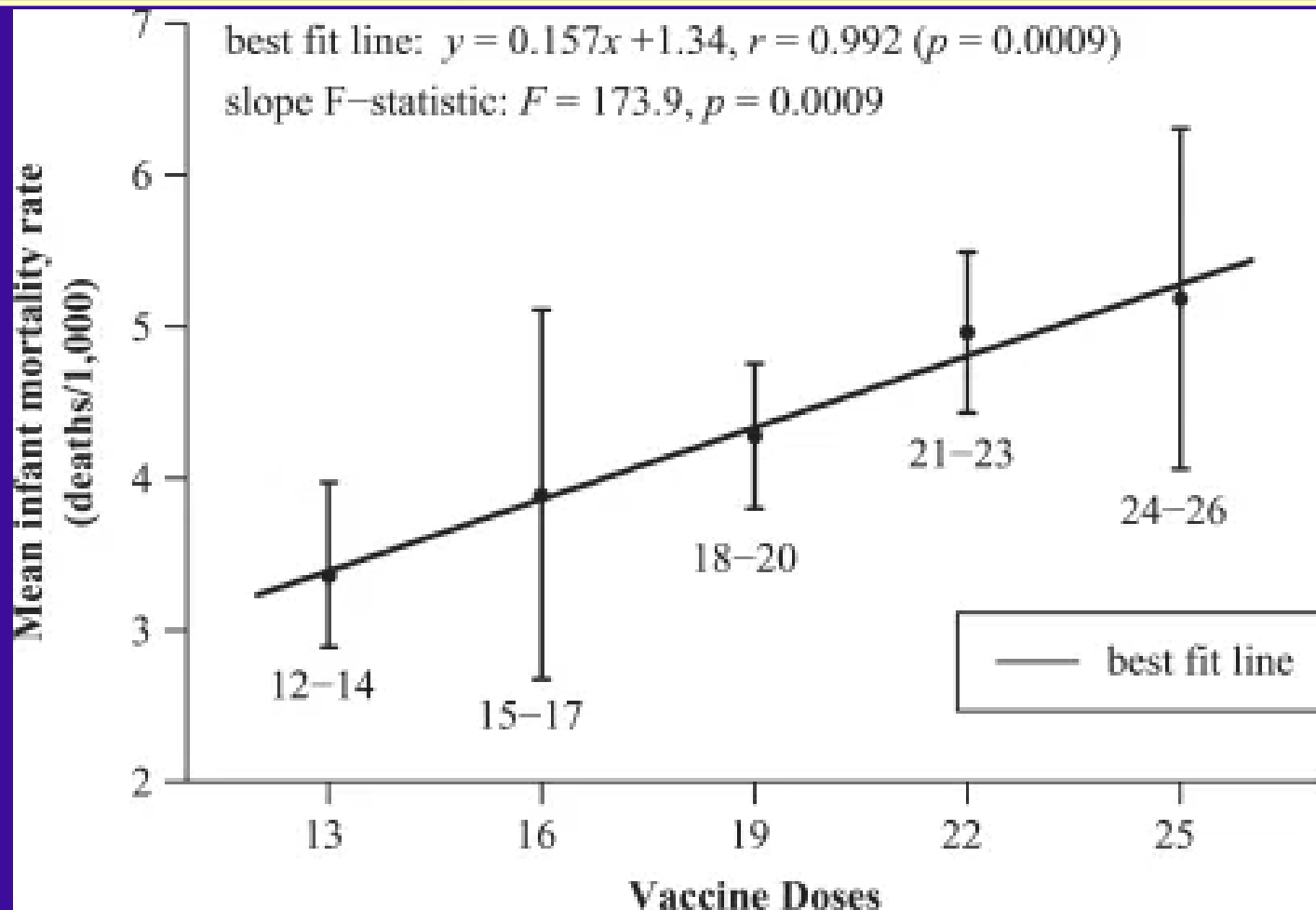
# Infant Mortality Data CDC

# House Bill 286, Informed Consent Protection Act

- Pennsylvania Congressman, Rep. Daryl D. Metcalfe, (R)
- Bill 286 makes it illegal for doctors to accept bonuses or other incentives from insurance or drug companies for vaccinating patients.
